Acceptance of a student placement with this agency indicates the field/practicum instructor and/or task supervisor agrees to:

- Provide a <u>minimum</u> one hour per week of supervision.
 - a) Supervision should be provided by a field/practicum instructor who has been awarded a BA in social work (for supervision of BA students) or MSW (for supervision of BA and MSW students) from a CSWE-accredited program with a minimum of two years post-degree practice experience.
 - b) The instructor should have either demonstrated competency in the area of practice being identified for the placement or have supervisory experience.



- Attend the Field/Practicum Orientation.
- Assist the student in development of the learning contract.
- Participate in scheduled student evaluations and submit student assessments in a timely manner.
- Discuss the following expectations with the student, including:
 - a) Completion of background check, if required
 - b) Completion of health screenings, drug screenings and immunizations, if required
 - c) Review COVID-19 precautions the agency has put in place to protect the safety and well-being of staff, students and community members receiving service
 - d) Completion of agency trainings, if required
 - e) Review the agency's policies, rules, regulations, safety protocols and standards of conduct pertaining to the student's placement
 - f) Discussion about how the student and field/practicum instructor wish to handle differences or conflicts
 - g) Review expectations regarding client transportation. Please note that the University of Iowa's liability policy does not cover transportation of clients. If the student will be driving the company vehicle, discuss with the student the insurance coverage the agency provides. If the student will be expected to transport clients in the student's own vehicle, the student will need to confirm that the student's personal car insurance will cover this.

The University of Iowa School of Social Work agrees to provide a faculty liaison that will coordinate activities between the agency, student and School.

Statement of Diversity and Inclusion

- Foster intercultural dialogues, examine individual biases, and critically analyze intersections of privilege and oppression.
- Expand students' understanding of cultural diversity by helping them explore other cultures through researching and participating in/supporting community events.
- Demonstrate empathy in a culturally sensitive manner, to listen, and work to solve problems peacefully.
- Create a community that is a safe environment for all.
