  - Qualified practicum instructor for BASW students: has BSW or MSW in social work from CSWE-accredited program plus two years post-degree practice experience; for MSW students: has MSW plus two years postdegree experience.
  - o The instructor should have demonstrated competency in the practice area and/or supervisory experience.
- Complete practicum supervisor orientation with the School of Social Work.
- Assist the student in development of the learning plan
- Facilitate opportunities to allow student to demonstrate the nine social work competencies.
- Provide a learning environment that reinforces the nine competencies, including ethics, social justice, and ADEI.
- Participate in scheduled student evaluations and submit student assessments in a timely manner.

- Discuss the following expectations with the student, including:
  - a) Completion of background check, health screenings, drug screenings and immunizations, if required
  - b) Completion of agency trainings, if required
  - c) Agency policies, rules, regulations, safety protocols, and standards of conduct related to the practicum
  - d) How the student and practicum instructor wish to handle differences or conflicts
  - e) Expectations regarding client transportation. The University of Iowa's liability policy does not cover transportation of clients. If the student will be transporting clients, discuss with the student how to register with the insurance coverage the agency provides and if the student is expected to use their own vehicle or a company vehicle. Also discuss mileage reimbursement if the student must use their personal vehicle.

The University of Iowa School of Social Work agrees to provide a practicum liaison that will coordinate activities between the agency, student and School. All students in practicum are covered by professional liability insurance through the University.
